#### SECURE

This is the same system utilized by the U.S. Treasury for Social Security and other electronic payments. ACH transactions are designed to occur automatically and electronically and reduces the incidence of identity theft from the processing of paper checks with your payee information. Also, the electronic nature of ACH transactions means that the records cannot be stolen, lost or misplaced in the mailing system.

#### EFFICIENT

Your royalty payment will be deposited to your account by the 25<sup>th</sup> of the month due. Just verify the payment to your bank account/bank statement and the owner detail statement from Petro-Hunt, L.L.C.
